Sessions are designed to accommodate as much discussion as possible. Each panel, dialogue, and round table will have its own format. Where formal presentations are featured, presentations will be no longer than 20 minutes. Presentations will be precirculated to the chair in all cases, and to other members of the panel whenever possible. Panels are one hour; this leaves 20 minutes per presentation, plus 20 minutes for a discussion between the chair and the two panelists. Roundtables are also one hour; presenters will each speak for 10 minutes, then a discussion between the chair and panelists will go on for 30 minutes. 30 minutes of general discussion open to the audience, moderated by the chair, will follow both panels and roundtables.
